# Summary of Results

- Revenues were 43.5% higher year over year
- OEM and Direct business was 44% of total revenues and Internet Data Center was 13.7% of total revenues
- System business was 57.7% of total revenues
- Revenues by Geography:
  - US – 54.9%
  - Europe – 20.2%
  - Asia – 19.9%
  - Other – 5.0%
- 4<sup>th</sup> straight record quarterly high in revenues led by 57.7% system business with continued growth in Storage, Twin, GPU, MicroCloud and Switch.

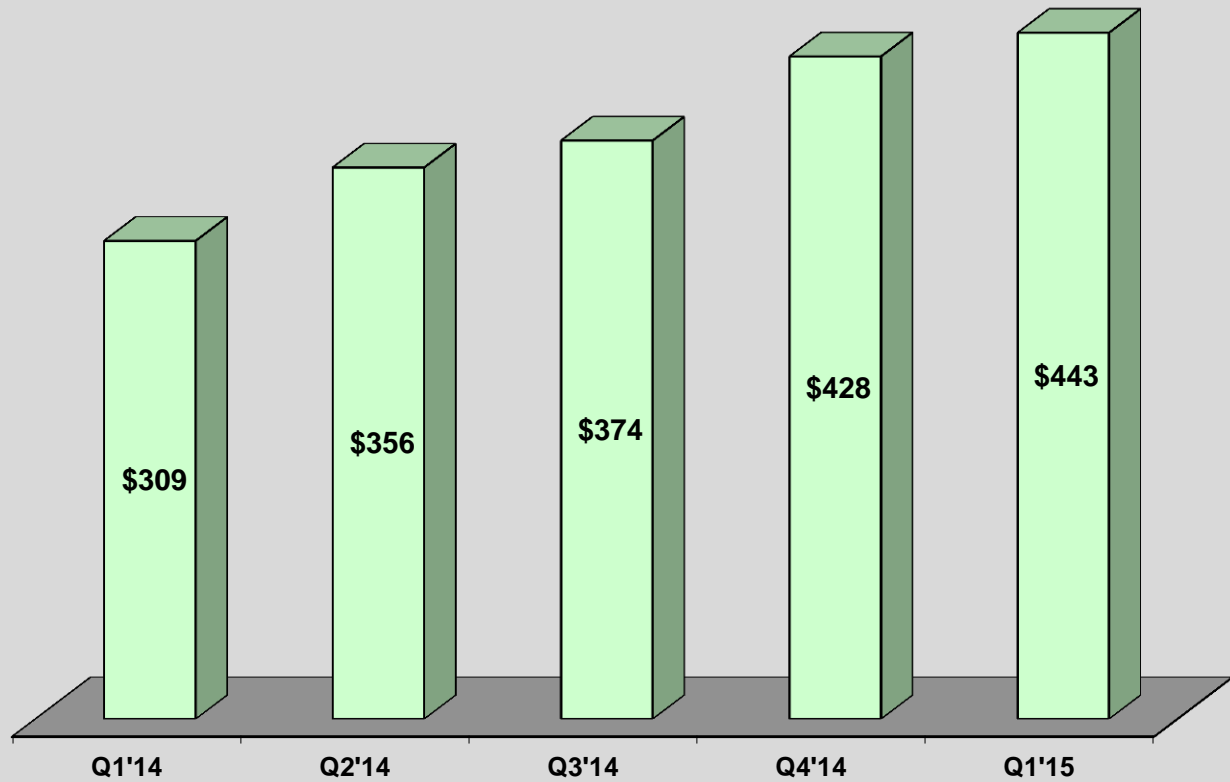
